	Mayor Houchen noted that a huge amount of work has gone into the Freeport Project by the Combined Authority and its constituent authorities. It was noted that the development of the final report had been dependent on several pieces of advice from across different Central Government Departments and Agencies.	
	Mayor Houchen thanked Councillor Lanigan for her contribution to the project.	
	Members questioned the rationale for the proposed Freeport Board membership which proposed that Jacob Young MP be appointed to represent all local interest. It was noted that Redcar and Cleveland Borough Council would also be represented. Members raised whether it would be beneficial for the MP representation to come from a different area within the Tees Valley to offer greater balance.	
	Mayor Houchen agreed to discuss this matter with Jacob Young MP and to keep the issue of the constitution of the Freeport Board under review.
