<b>TVCA 77/19</b>	<b>DECLARATIONS OF INTEREST</b>  The Tees Valley Mayor, Graham Robb and Cllr Mary Lanigan placed on record their membership of the Board of the South Tees Development Corporation (Item 80/19).
<b>TVCA 78/19</b>	<b>MINUTES OF PREVIOUS MEETING</b>  The minutes of the meeting held on March 13 <sup>th</sup> 2020 were confirmed as a true record.

<b>TVCA 80/19</b>	<b>TVCA GROUP GOVERNANCE</b>  The Tees Valley Mayor introduced a paper updating Cabinet on TVCA Group Governance arrangements, incorporating necessary amendments to give effect to the evolving Group structure and South Tees Development Corporation (STDC) Board composition and reflect the negotiated compromise agreement with SSI/Thai Banks, the successful Compulsory Purchase Order (CPO) process and the associated joint venture arrangements.  Cabinet was recommended to:  <ul style="list-style-type: none"> <li>i. Approved proposed amendments to the Group Governance arrangements and roles and responsibilities of Senior Officers and delegated the authority to the Tees Valley Mayor to approve any further necessary changes, provided their impact remained within the funding envelope detailed in the TVCA Medium Term Financial Plan;</li> <li>ii. Approved proposed changes to the membership of the STDC Board and agreed consequential changes to the STDC Constitution to enact this;</li> <li>iii. Delegated to the Chief Executive Officer, in consultation with the Director of Finance and Resources and the Monitoring Officer, the authority to make the necessary administrative arrangements to coordinate and manage the proposed amendments.</li> </ul> <b>RESOLVED that: Cabinet approved the recommendations as set out in the report.</b>

	<p>The Tees Valley Mayor introduced a report providing a general update on the key activities of the Mayor and Combined Authority since the last Cabinet meeting, in particular setting out the Combined Authority's response to the COVID-19 outbreak.</p> <p><b>RESOLVED that: Cabinet agreed to note the report.</b></p>
<p><b>TVCA 82/19</b></p>	<p><b>RESPONSE TO GOVERNMENT FREEPORTS CONSULTATION</b></p> <p>The Tees Valley Mayor introduced a report detailing the Combined Authority's proposed response to the Government's Freeports Consultation.</p> <p>Cabinet was recommended to support the submission of the consultation response to Government.</p> <p>Cllr Mary Lanigan expressed support for the proposals and praised the report.</p> <p>Jerry Hopkinson, Local Enterprise Partnership thematic lead for Transport &amp; Infrastructure, commented on the "profound impact" the proposal could have on the Tees Valley economy.</p> <p>Cllr Shane Moore thanked officers for incorporating feedback received from the Local Enterprise Partnership Board.</p> <p><b>RESOLVED that: Cabinet approved the recommendation and delegated to the Tees Valley Mayor the authority to make final revisions to the consultation response in consultation with local authority leaders.</b></p>
<p><b>TVCA 83/19</b></p>	<p><b>TRANSPORT INVESTMENT PROSPECTUS</b></p> <p>Under Section 100A (4) of the Local Government Act 1972 the Tees Valley Mayor proposed that the public be excluded from the meeting for the duration of the following item.</p> <p>Tom Bryant, Head of Transport &amp; Infrastructure, introduced a report setting out Combined Authority proposition for a share of the five-year transport funding settlement for eight Mayoral Combined Authorities announced in the Budget.</p> <p>Cabinet was recommended to:</p> <ol style="list-style-type: none"> <li>i. Approve the Transport Investment Prospectus.</li> <li>ii. Authorise the Chief Executive and Tees Valley Mayor to engage with Government and make any necessary amends to the Transport Investment Prospectus in consultation with Tees Valley Management Group.</li> <li>iii. Approve an allocation from the TVCA Investment Plan 2019-2029 as a local contribution to the new A19 Tees Crossing, subject to the production of a Full Business Case and due diligence in line with the Assurance Framework.</li> </ol> <p>Graham Robb queried whether more funding should be made available to support the installation of electric vehicle charging points at places of work. Tom Bryant stated that funding levels in the prospectus were currently indicative only, and that funding for project of this nature was expected from other channels, with an emphasis on the development of a public network.</p>

	<p>Paul Booth and Jerry Hopkinson expressed support for the proposals and requested that members be provided with additional information with regards to the development of hydrogen vehicles in the Tees Valley and digitisation of the regional transport network. The Tees Valley Mayor recognised that requests may require specific additional submissions to the government.</p> <p><b>RESOLVED that: Cabinet approved the recommendations as set out in the report.</b></p>
