Members (including co-opted Members) should consider whether they have a personal interest in any item, as defined in **paragraphs 9 and 11** of the Tees Valley Combined Authority's (TVCA) code of conduct and, if so, declare the existence and nature of that interest in accordance with and/or taking account of **paragraphs 12 - 17** of the code.

Where a Member regards him/herself as having a personal interest, as described in **paragraph 16** of the code, in any business of the TVCA he/she must then, in accordance with **paragraph 18** of the code, consider whether that interest is one which a member of the public, with knowledge of the relevant facts, would reasonably regard as so significant that it is likely to prejudice the Member's judgement of the public interest and the business:

- affects the Member's financial position or the financial position of a person or body described in **paragraph** 17 of the code, or
- relates to the determining of any approval, consent, licence, permission or registration in relation to the Member or any person described in **paragraph 17** of the code.

A Member with a personal interest, as described in **paragraph 18** of the code, may attend the meeting but must not take part in the consideration and voting upon the relevant item of business. However, a Member with such an interest may make representations, answer questions or give evidence relating to that business before the business is considered or voted on, provided the public are also allowed to attend the meeting for the same purpose whether under a statutory right or otherwise (**paragraph 19** of the code).

Disclosable Pecuniary Interests

It is a criminal offence for a Member to participate in any discussion or vote on a matter in which he/she has a disclosable pecuniary interest (and where an appropriate dispensation has not been granted) (**paragraph 20** of the code).

Members are required to comply with any procedural rule adopted by the TVCA which requires a Member to leave the meeting room whilst the meeting is discussing a matter in which that Member has a disclosable pecuniary interest (paragraph 21 of the code).

TVCA DECLARATIONS OF INTEREST 92/16

Councillors Sue Jeffrey, Christopher Akers-Belcher, Bill Dixon, Bob Cook and David Budd declared an interest in Agenda Item 6, South Tees Development Corporation, as members of the Shadow South Tees Development Corporation Board.

TVCA MINUTES 93/16

Consideration was given to the minutes of the meeting held on 22nd February 2017.

RESOLVED that the minutes of the meetings held on 22nd February 2017 be confirmed and signed as a correct record.

TVCA ANNOUNCEMENTS FROM THE CHAIR 94/16

The Chair confirmed that all matters were covered on the agenda.

TVCA INDUSTRIAL STRATEGY CONSULTATION 95/16

The Board considered a report that provided an update on the preparation of the Combined Authority's response to the Industrial Strategy consultation.

It was noted that the Tees Valley's Strategic Economic Plan, as the Industrial Strategy for Tees Valley, identifies the strong contribution that the area will make to the UK's Strategy.

The Board asked that the following comments be factored in to the response:

- Importance of ensuring the supply of energy and raw materials;
- The importance of the Tees Valley economy to national productivity;
- Ensuring a bigger profile abroad in light of Brexit;
- The 'Developing Skills' Pillar being closely aligned with the Investment Plan and activity should be tailored to the needs of the Tees Valley;
- Ensuring recognition of new enabling technologies (e.g. Carbon Capture and Storage) and their role in sustaining traditional industry;
- The above average business startup rates in Tees Valley.

The closing date for the industrial strategy consultation was 17th April.

RESOLVED that the preparation of the final submission be delegated to the Managing Director in consultation with the Chairs of the Combined Authority and the Local Enterprise Partnership.

TVCA SOUTH TEES DEVELOPMENT CORPORATION 96/16

The Board considered a report that set out the summary of responses to the

consultation on the proposal to create a Mayoral Development Corporation (MDC) in the South Tees Area and the proposed next steps to progress the area.

The statutory provisions giving the power to the Combined Authority to create MDCs had now gone through Parliament. The Tees Valley was the first area outside of London to be given these powers.

The Combined Authority had received 29 responses to the consultation and a summary of the responses was provided to the Board. Responses had been positive on the whole with respondents agreeing that the establishment of the Mayoral Development Corporation was the most effective way to deliver regeneration and economic transformation on the site.

The following areas of the consultation summary were highlighted to the Board:

- Tata Steel had requested that the boundary be extended to include all Tata Steel owned land. This extended the boundary by 60ha and brought Coatham Marshes in to the area, which was managed by Tees Valley Wildlife Trust. Consultation on the proposal had been undertaken with all appropriate parties and had been agreed;
- The Institute of Directors had also highlighted that they saw an opportunity to include Wilton within the boundary. A verbal update on this was given at the meeting. A partnership between Wilton and the South Tees Development Corporation was considered to be the most effective way of ensuring support and opportunities were available on both sites;
- Planning powers were to be retained by Redcar and Cleveland Borough Council. The Council's planning function had considerable experience with complex industrial sites and this would be applied in close partnership with the Development Corporation;
- Robust management of risks and liabilities arising from the site and a strong commitment from Government to meet its obligations to fund the costs came through in a number of responses.

The Board welcomed the positive responses and the process undertaken so far to progress the establishment of the Mayoral Development Corporation. The Board reiterated the importance of the need for continuing government support.

The Chair laid the proposal to the Combined Authority Board that the South Tees area, as defined in the map presented to the Board, be progressed as a Mayoral Development Corporation. This would then enact a 21 day consideration period to allow Combined Authority Board members to make any further comments. During this period, the views of the Overview and Scrutiny Committee would be sought on 4th April. The drafting of specific legislation would also begin and financial and constitutional arrangements would be developed.

Subject to the 21 day consideration period, and the views of the Overview and Scrutiny Committee, it was expected that the Mayor would formally designate the South Tees Development Corporation at a future meeting of the Cabinet.

RESOLVED that:

- 1. The approval of the Tees Valley (Functions) Order 2017 by parliament be noted.
- 2. The outcome and responses to the consultation on applying the powers to the South Tees Development Corporation be noted;
- 3. The proposal to progress the South Tees Development Corporation as a Mayoral Development Corporation be agreed in principle, with its area of responsibility as set out at Appendix 2;
- 4. The views of Overview and Scrutiny Committee be sought;
- 5. Officials be mandated to work with DCLG on the development of the necessary legislation, and prepare draft constitutional and financial arrangements for the proposed Corporation;
- Proposals for the creation of the South Tees Development Corporation, its constitutional and financial arrangements, be brought forward for approval at a future meeting, and notification to the Secretary of State – with a view to establishing the new body in Summer 2017.

TVCA 97/16

COMBINED AUTHORITY INVESTMENT PLAN

The Board considered a report which presented the first Investment Plan of the Combined Authority – "Investing in Tees Valley's Future". The Investment Plan brought together all of the funding sources the Combined Authority's had to invest in to a single pot, over the period 2017 – 2021.

It set out how the Combined Authority was delivering existing commitments, the approach to future investment, including the impact of Brexit, the headline programme for future investment and highlighted some specific priorities. The Plan had been developed in close partnership with key partners, including the five Local Authorities. As a key document of the Combined Authority, the Investment Plan required the unanimous approval of the Board.

The Board welcomed the Investment Plan and the importance of its role as a framework for investment over the longer term. In particular, the commitment to the development pot to allow the pump priming of projects was welcomed.

The Investment Plan would now be published and used as a framework to bring forward proposals to the Board in the coming months. It was noted that the Investment Plan would be reviewed in autumn 2017, in line with the requirements of the Assurance Framework.

RESOLVED that the Investment Plan be approved.

TVCA 98/16

COMBINED AUTHORITY BUDGET 2017/18

The Board considered a report that presented the Combined Authority Budget for 2017/18. The Board considered the Budget at its meeting on 31st January, prior to the commencement of a consultation period. As part of the consultation period the Budget was considered by the Overview and Scrutiny Committee, and the Committee had indicated their endorsement. The consultation period had now closed and the Budget had been brought

back to the Board for final approval.

The Board was also informed of a number of funding allocations that had been secured by the Combined Authority since the 31st January, and these were reflected within the Budget.

The Board welcomed the additional funding that had been secured but reiterated their disappointment with government over the Local Growth Fund allocation for the area.

RESOLVED that:

- The Overview and Scrutiny Committee's endorsement of the Budget be noted;
- 2. The Budget for 2017/18 be approved;
- 3. The new funding allocations secured since 31st January be noted;
- 4. The funding from the Pothole Action Fund be allocated to the Constituent Councils, as set out in the report;
- 5. The funding position on concessionary fares, as set out in the report, be agreed, with any final amendments to be delegated to the Managing Director in consultation with the Chair.

TVCA CULTURE AND TOURISM

99/16

The Board considered a report which identified proposals for initial investment in culture and tourism using devolution and devolvement funds. The focus was on expanding the visitor economy and ensuring a strong contribution to the Strategic Economic Plan from the Culture and Tourism sector. Investment activity would be focused around heritage and attraction asset capital development, festivals and events, building cultural capacity and putting in place a destination marketing function to promote the culture and tourism offer within the region, nationally and internationally.

The Board welcomed the programme and acknowledged the role it would have in beginning to lay the groundwork for a successful bid for the Tees Valley to be 2025 City of Culture. The importance of Executive Member involvement in the process going forward was highlighted and the Board requested that governance proposals be presented to a future meeting.

RESOLVED that:

- 1. The focus of the initial culture and tourism investment programme be noted:
- 2. The total programme of £1.8m be agreed for the following activities (subject to due diligence through the Assurance Framework):
 - a. Heritage and Attraction Asset Capital Development (£250,000);
 - b. Festivals and Events (£200,000 x 2 years);
 - c. Building Cultural Capacity (£100,000);
 - d. Destination Marketing (£350,000 x 3 years).

TVCA TEES VALLEY HOUSING AGREEMENT

100/16

The Board considered a report which provided an update on progress with

the Tees Valley Housing Agreement. As part of the devolution deal signed in October 2015, the government committed to working with the Tees Valley Combined Authority to explore the devolution of housing funding.

Proposals for the Agreement have therefore been developed, working with key partners both locally and nationally, to put in place a collaborative framework in which government makes available over £100m of funding for an accelerated home building programme. The programme would enable more than 2,500 good quality affordable homes to be built by 2021.

The Combined Authority had submitted a proposal to the Homes and Communities Agency in this respect and this was currently under consideration however it was noted that at this stage, full devolution was not an option.

Following the election of the Mayor in May, the Combined Authority would bring forward a strong proposal to the Cabinet, with government to invest alongside this.

RESOLVED that progress on the Tees Valley Housing Agreement be noted.

TVCA SCRUTINY RULES OF PROCEDURE

101/16

The Board considered a report that presented the final Rules of Procedure for the Overview and Scrutiny Committee, including the call-in arrangements, for inclusion in the Combined Authority Constitution.

The Board acknowledged the important role of the Overview and Scrutiny Committee since the establishment of the Combined Authority

RESOLVED that the Overview and Scrutiny Committee Rules of Procedure be approved for inclusion within the Combined Authority Constitution.

TVCA 102/16

EXCLUSION OF THE PUBLIC

RESOLVED that under Section 100A(4) of the Local Government Act 1972 the public be excluded from the meeting for the following item of business on the grounds that it involves the likely disclosure of exempt information as defined in paragraphs 1 and 2 of Part 1 of Schedule 12A of the Act.

LEP BOARD MEMBERSHIP

The Board considered a report that made recommendations for a number of appointments to the Local Enterprise Partnership Board. It also notified the Board that Alastair MacColl and David Robinson had taken the decision to stand down to focus upon other business opportunities.

The Combined Authority had also received a a proposal from six business representative groups (North East England Chamber of Commerce; Confederation of British Industry; Federation of Small Businesses; Engineering Employers Federation; Tees Valley Business Club; and Entrepreneurs Forum), to appoint a single representative to the Board with 'Observer Status'. This appointment would be confirmed at the AGM in May.

The Board indicated their full support for the new appointments and acknowledged the contribution of retiring members.

REPORT TO THE TEES VALLEY COMBINED AUTHORITY CABINET

31 MAY 2017

REPORT OF THE MANAGING DIRECTOR

ANNUAL MEETING BUSINESS AND APPOINTMENTS

SUMMARY

This report details a number of items for agreement and confirmation by the Combined Authority Cabinet at its Annual General Meeting (AGM). This is the first meeting of the Combined Authority Cabinet under the new legislation, and following the election of the first Tees Valley Mayor.

RECOMMENDATIONS

It is recommended that the Combined Authority Cabinet agrees the appointments as set out at Appendix 1.

DETAIL

- 1. The Combined Authority Constitution and legislative framework came in to effect on 8th May 2017, following the election of the new Tees Valley Mayor on 4th May. The Constitution provides an important framework for the operation and governance of the Combined Authority, and was developed in close consultation with the Constituent Authorities.
- 2. There are a number of items of business that the Combined Authority Cabinet is required to confirm at the AGM, and these are set out below.

Appointments

3. The Cabinet is recommended to agree a number of appointments to its statutory committees, for the municipal year 2017/18. The appointments schedule at **Appendix 1** details the nominations to the statutory committees. It also details a number of non-statutory/advisory board appointments, external appointments and confirmation of statutory officers.

- 4. In total, the appointments schedule identifies 131 individuals: including councillors, business representatives, voluntary sector representatives and sector experts. In addition, a further 79 individuals have come forward to form a Business Leadership Group, to ensure the work of the Combined Authority benefits from a wider range of private sector involvement. This approach provides a model of collective leadership and involvement, building on the strong partnership approach established by the Combined Authority and Local Enterprise Partnership.
- 5. In summary, appointments are being made to the following groups:
 - Deputy Mayor under our Constitution, the role of Deputy Mayor circulates annually amongst the Council Leaders. It is therefore proposed that Cllr Bob Cook, Leader of Stockton-on-Tees Council, becomes the Deputy Mayor for the 2017-18 municipal year.
 - Cabinet the Cabinet is the decision making body for the Combined Authority. The Mayor chairs the Cabinet, made up of the five Constituent Authority Leaders, and the Chair of the LEP as a non-voting member. The Council Leaders have made proposals for the allocation of portfolio responsibilities.
 - Overview and Scrutiny Committee the purpose of the committee is to review the policies and operations of the Combined Authority, ensuring effective democratic scrutiny of decisions. Under new legislation, the Committee also has the power to call-in decisions for review, before they are implemented.
 - Transport Committee the purpose of this statutory committee is to review
 the transport strategy and policies of the Combined Authority and to make
 recommendations to Cabinet. The committee enhances collaboration by
 bringing together the executive members with transport responsibilities from
 the five councils.
 - Audit and Governance Committee the committee will assure sound governance, effective internal control and financial management of the Combined Authority.
 - The Land Commission under arrangements agreed in the Devolution Deal, the Land Commission will maximise the use of brownfield land and land owned by Government departments and agencies, to support economic development and new homes.
 - Education, Employment and Skills Partnership Board this board brings together a wide range of partners to provide strategic oversight, advice and recommend actions to the Cabinet on policies to improve educational outcomes, enhance skills and help people into work.
 - Culture and Tourism Partnership Board this board brings together
 partners working to improve the Tees Valley's cultural offer, and to grow the
 visitor economy; including planning for a bid to be City of Culture 2025, and to
 create a new destination marketing function.

- Innovation Task Group this group brings together experts on innovation and technology, provide expertise and guidance on specific initiatives and policies as part of the Tees Valley's industrial strategy.
- Transport Advisory Group this group brings together officers and partners with responsibilities for the Tees Valley's transport infrastructure, to develop proposals for investment and improved services.
- Business Compass Steering Group the group oversees the Tees Valley's business growth services, ensuring the Business Compass service is providing good quality support to help businesses to grow.

Local Enterprise Partnership Membership

- 6. The Local Enterprise Partnership (LEP) is the principal forum for collaboration between the public and private sectors, forming part of a national network of LEPs. Under unique arrangements for the Tees Valley, LEP Board members are also appointed as Associate Members on the Cabinet.
- 7. Two new members are recommended to the LEP Albi Pattison and Graham Robb:
 - Albi Pattison is the owner manager of Hart Biologicals Ltd in Hartlepool. The business is a specialist medical device development and manufacturing company. Albi has a strong interest in education and encouraging links between schools and businesses to improve the provision of science careers advice.
 - Graham Robb is the founder of Recognition PR, the North East's largest media relations business, based in Darlington. Graham was the former regional chairman of the Institute of Directors and is currently vice-chair of the Entrepreneurs' Forum.
- 8. Both Albi and Graham provide additional sector expertise currently not covered by the LEP members.
- 9. Government officials are currently reviewing good practice in the operation of Local Enterprise Partnerships, including the application of rules on conflicts of interest and transparent decision-making. As a Combined Authority, the Tees Valley has in place specific governance requirements which ensure a high standard of propriety. Nevertheless, in the light of new national guidelines, and the specific governance arrangements that now apply in the Tees Valley, it is recommended that the Managing Director conduct a review of the obligations on LEP members in order to assure that the Tees Valley is fully in line with national best practice.

Appointments to External Bodies

10. The appointment schedule also proposes Tees Valley representation by the Mayor and other members on a small number of external bodies; including Transport for the North, the Local Government Association and the Key Cities network. Appointments are also made to various officer groups which ensure the five councils and the Combined Authority are working closely together on key policies and proposals. The schedule also confirms the appointment of the Combined Authority's Statutory and Chief Officers.

- 11. The Cabinet is recommended to formally agree the appointments as presented in **Appendix 1**. Because of the timings of Annual Meetings of the constituent councils, some of the appointments of elected members are subject to confirmation by their respective councils. A small number of vacancies remain on a number of groups, and will be brought forward for agreement by Cabinet at future meetings.
- 12. Under our constitution, members of the Overview and Scrutiny Committee and the Audit and Governance Committee are invited to propose their own chairs and vie-chairs; within constraints set by the legislation. These appointments will therefore be brought to the July meeting of the Cabinet for confirmation, following meetings of both Committees at the end of June.

Delegations

- 13. As set out in the Constitution, the Cabinet is the decision making body for the Combined Authority. The Cabinet can delegate decision-making powers to any of its Sub-Committees and also to the Managing Director or other Chief Officers, as defined by the Constitution. This has already been agreed in relation to utilisation of the Development Fund, to support the assessment of proposals prior to decision-making, delegated to the Managing Director in consultation with the Mayor. This delegation is set out in the appropriate appendix to the Constitution along with a number of other standard operational and procedural delegations (e.g. contracts and accounts) that are already in place to the Chief Officers.
- 14. The establishment of portfolio holders for Cabinet Members provides the opportunity to consider further delegations, for matters within established Combined Authority policy and our Investment Plan, below a set financial value, and which can be determined without the need for a discussion at a full Cabinet meeting. Proposals on delegations for approval jointly by the Mayor and Cabinet portfolio holder will therefore be brought to a future meeting of the Cabinet for consideration.

Members' Allowances Scheme and Mayoral Allowance

15. The Combined Authority has already established its proposed framework for the Mayor's allowance. Following a recommendation from the Independent Remuneration Panel, the Mayor's allowance will be set as the average of the 5 Constituent Authorities' Leaders' allowances, to be reviewed in early 2018. By applying this approach to the 2017-18 municipal year, the Mayor's allowance is set at £36,058. Travel and subsistence allowances are payable for official business, at rates set out in the transparency section of the Combined Authority website.

FINANCIAL IMPLICATIONS

16. Support for the governance of the Tees Valley Combined Authority is provided from within the Authority's core budget, as agreed by Cabinet through the annual budget process, and funded through resources devolved from central government.

LEGAL IMPLICATIONS

17. The report relates to the Constitution for the Combined Authority which sets out the appropriate statutory framework. The Constitution came in to effect on 8th May 2017 and is legally binding.

RISK ASSESSMENT

18. This report is categorised as low to medium risk. Existing management systems and daily routine activities are sufficient to control and reduce risk.

CONSULTATION

19. The five Constituent Local Authority Leaders have been appropriately consulted on appointments, and nominations have been made through each council. The incoming Mayor has also been consulted on these proposals.

RECOMMENDATIONS

20. It is recommended that the Combined Authority Cabinet agrees the appointments as set out at Appendix 1.
