63/19	Apologies were received from Nigel Perry (CPI), Mark South (Double 11) Brenda McLeish (Learning Curve) Professor Paul Croney (Teesside University) and Cllr Mary Lanigan (Redcar & Cleveland Borough Council).

64/19	The minutes of the meeting of January 13 th 2020 were agreed and signed as a true record. The Governance Manager reported that all items on the Action Tracker were up-to-date.	
LEP	PRESENTATION FROM THE ENVIRONMENT AGENCY	
65/19	 Eddie Halstead from the Environment Agency gave a presentation to members detailing recent and planned flood prevention investment in the Tees Estuary, including: £15.5m completed investment in Greatham and Port Clarence, protecting 350 homes and 32 businesses. £30m planned investment in Portrack Lane, Teesside Park and Seal Sands North, expected to deliver £500m of economic value. 	
	Members were requested to support the Environment Agency in making a business case for these projects, particularly in terms of providing supporting evidence and amplifying the message through member networks.	
	Graham Robb requested an update on recent flooding, whether remedial work had been undertaken in the Portrack area following previous floods, and whether dredging of the South Bank area would assist with flood prevention.	
	Catherine Saxon reported that local assets had performed well during the recent heavy rain, and post-event analysis was being undertaken. She stated that dredging would in all likelihood deliver only marginal benefits and would not be cost effective. Cllr Bob Cook confirmed that steps had been undertaken by Stockton Borough Council to address previous flooding in the vicinity of Durham Road.	
	Zoe Lewis highlighted the impact of flooding in the Middlehaven area in 2009 and the development of the Outwood Academy on the affected area. Eddie Halstead confirmed that this area was under analysis and review.	

	Siobhan McArdle requested further detail as to calculation of the £500m of economic value. Eddie Halstead stated that the figures has been developed using the Treasury Green Book. The Chair drew member's attention to the disruption to the local chemical cluster caused by the 2013 tidal surge. RESOLVED THAT: Members expressed that they would like a follow up discussion with the Environment Agency with regards to the economic impact of flood risk and how the LEP and Combined Authority can work with them to achieve priorities.

	The Mayor also updated members on engagement with the offshore wind sector undertaken by STDC and developments with the sale of British Steel and thanked Julie Gilhespie and Gary Macdonald for their assistance in negotiations. The Chair reported, as Chair of the South Tees Site Company, that access to parts of the site remained limited due to the ongoing Health and Safety Executive Investigation. Cllr Bob Cook asked if the deal would deliver financial savings in terms of budget headings previously allocated for the acquisition of	
	the land. The Tees Valley Mayor and Chair acknowledged that this would be the case but drew members attention to the significant costs of demolition work necessary on the site.
