ECONOMIC RECOVERY PLANNING

Chris Beck, Combined Authority Director of Business & Skills gave a presentation updating members on the Combined Authority's proposed support package to protect the local economy and enhance regional growth prospects following the disruption of the COVID-19 outbreak, which will be divided into six themes:

TEES VALLEY BUSINESS

Chris Beck updated members on the transition from Tees Valley Compass to Tees Valley Business as the regional business support service, which was completed on July 1st 2020.

The Chair welcomed the change, and recommended that consideration be given as to how best to promote the business to Tees Valley SMEs.

Rachel Anderson, North East England Chamber of Commerce, asked if the service would offer enhanced support for start-ups. Chris Beck confirmed that it would, and the most appropriate delivery mechanism for this service was currently being considered.

ROUNDTABLE OF MEMBER UPDATES

Members provided updates on their areas of responsibility.

David Soley updated members on the impact of COVID-19 on the hospitality sector, in particular how:

- The relaxing of social distancing measures had allowed a clear majority of venues to re-open.
- Issues relating to government support loans had been resolved.
- The Combined Authority Welcome Back fund had been well received by the sector.

Annabel Turpin also highlighted the positive response to the Welcome Back fund in the cultural sector.

As Chair of Teesside International Airport, David Soley also updated members on the re-introduction of services from the airport, progress of the South Side development, plans for Summer 2021 routes and the commencement of new commercial tenancies on the airport site.

Simon Hanson highlighted the impact of rising insurance costs for small business, which are in some cases hampering businesses efforts to re-open following the COVID-19 disruption. These concerns were echoed by David Soley.
