Lyndsay has provided ground-level support, such as donating 18,000 packets of sanitary products across her hometown and starting a campaign to have these provided free in all Hartlepool businesses – with many joining the initiative countrywide. She also coordinated the town's response to send medical aid to Ukraine, sending 10 trucks in total and raising £13,000.

Hogg Global Logistics also became the first (and only) North-East business to win the King's Award for Enterprise in International Trade – completing the process herself from start to finish. This demonstrates the company's standards for excellence in its industry.

He was elected as the first Mayor of the Tees Valley in 2017 and was re-elected in 2021 with 73% of the vote. He was then elected for a third term in 2024 and currently continues to serve as the elected Mayor.

In his first term, Ben successfully delivered his manifesto pledge to save Teesside Airport from closure and is continuing to deliver the 10-year Rescue Plan for the airport.

He is responsible for establishing the first Mayoral Development Corporation (South Tees Development Corporation - Teesworks) outside of London, second only to the Olympic Park – which was set up for the 2012 Olympics. The Development Corporation is responsible for the regeneration of the largest brownfield site in western Europe, which has attracted billions of pounds in foreign direct investment and is creating thousands of manufacturing jobs in industries like offshore wind, hydrogen and carbon, capture and storage. He has also created two more Mayoral Development Corporations to help regenerate Middlesbrough and Hartlepool town centres.

He has also helped to deliver national policies to help level up the country, including being one of the architects of the UK's Freeport policy. As a result, he was able to establish the UK's first and largest freeport – the Teesside Freeport. He also worked closely with Government to bring the newly established Treasury Economic Campus to Darlington, which is the premier home for the Treasury outside of London.

Cleveland Police and Crime Commissioner (currently Matt Storey)



The role of the Police and Crime Commissioner (PCC) is to be the voice of the people and hold the police to account. They are responsible for the totality of policing. They are elected by the public to hold Chief Constables and the force to account, to cut crime, deliver an effective and efficient police service within their police force area, most importantly, making the police answerable to the communities they serve.

PCCs must ensure community needs are met as effectively as possible and are tasked with improving local relationships through building confidence and restoring trust. They work in partnership across a range of agencies at local and national level to ensure there is a unified approach to preventing and reducing crime.

Under the terms of the Police Reform and Social Responsibility Act 2011, PCCs must:

- secure efficient and effective police for their area.
- appoint the Chief Constable, hold them to account for running the force, and if necessary, dismiss them.
- set the police and crime objectives for their area through a police and crime plan;
- set the force budget and determine the precept;
- contribute to the national and international policing capabilities set out by the Home Secretary; and
- bring together community safety and criminal justice partners, to make sure local priorities are joined up.



He is responsible for establishing the first Mayoral Development Corporation (South Tees Development Corporation - Teesworks) outside of London, second only to the Olympic Park – which was set up for the 2012 Olympics. The Development Corporation is responsible for the regeneration of the largest brownfield site in western Europe, which has attracted billions of pounds in foreign direct investment and is creating thousands of manufacturing jobs in industries like offshore wind, hydrogen and carbon, capture and storage. He has also created two more Mayoral Development Corporations to help regenerate Middlesbrough and Hartlepool town centres.

He has also helped to deliver national policies to help level up the country, including being one of the architects of the UK's Freeport policy. As a result, he was able to establish the UK's first and largest freeport – the Teesside Freeport. He also worked closely with Government to bring the newly established Treasury Economic Campus to Darlington, which is the premier home for the Treasury outside of London.

The role of the Police and Crime Commissioner (PCC) is to be the voice of the people and hold the police to account. They are responsible for the totality of policing. They are elected by the public to hold Chief Constables and the force to account, to cut crime, deliver an effective and efficient police service within their police force area, most importantly, making the police answerable to the communities they serve.

PCCs must ensure community needs are met as effectively as possible and are tasked with improving local relationships through building confidence and restoring trust. They work in partnership across a range of agencies at local and national level to ensure there is a unified approach to preventing and reducing crime.

Under the terms of the Police Reform and Social Responsibility Act 2011, PCCs must:

- secure efficient and effective police for their area.
- appoint the Chief Constable, hold them to account for running the force, and if necessary, dismiss them.
- set the police and crime objectives for their area through a police and crime plan;
- set the force budget and determine the precept;
- contribute to the national and international policing capabilities set out by the Home Secretary; and
- bring together community safety and criminal justice partners, to make sure local priorities are joined up.

Matt has since been a Councillor in Middlesbrough since 2016 representing Central Ward and was Labour Group Leader between 2019 and 2023 and Chair of the Overview and Scrutiny Board until May 2024.
