OSC OF/24	Work Programme
05/24	Members received a report from the Governance and Scrutiny Manager which presented an initial draft work programme for 2024/25. The report included responses from Cabinet members on the proposed work programme, subject to the Committee agreeing on areas to review.
	The report noted the intention for the Committee to establish a Sub-Committee in relation to Finance and Resources to consider budget proposals as part of the overall budget consultation process.
	The Chair suggested that the Committee received an update on implementation of the Scrutiny Protocol at its September meeting. To aid Members that were new to the Committee it was considered beneficial to provide all members of the Committee with the agenda, reports and minutes of the Scrutiny Protocol Sub-Committee session that took place in April 2024.



The following key areas were considered by the Committee:

## **Review of Transport**

Members considered the connected nature of different transport operations, with a particular focus on roads, buses and rail operations. It was noted that as part of the agenda pack, the Committee had been provided with responses from Cabinet members on suggested issues to review.

## Education, Skills, and Employment

Members highlighted a growing disconnect between individuals and skills required by Business, partly due to the growth in technology.

Several areas were suggested for inclusion as part of the review as follows:

- **Adult/ Youth skills programmes:** Work being done to support adults and young people through the skills budgets.
- **Transport / Skills:** Members noted that the two areas were linked, enhanced transportation supported access to employment and skills. Members discussed that transport should not be a barrier to opportunities.
- **Job Creation / Skills gap:** Members were keen to explore the potential for job creation within the region and the skills gap.

Members were advised that the broad themes were to be agreed by the Committee and it was the role of the Sub-Committees to undertake in-depth review work and report back to the Committee to consider its findings and agree a way forward.

The Committee agreed to undertake two in-depth reviews as follows:

- 1) Transport; and
- 2) Education, Employment, and Skills.
