1. By entering the competition, you accept these terms and conditions.
2. These terms are in addition to any conditions detailed in the marketing material about the prize draw (the "marketing material").
3. **PURPOSE:** The purpose of this competition is to promote Visit Tees Valley and offer the chance to win a family pass to the new visitor attraction on Teesside, Ninja Warrior
